ARTICLES OF INCORPORATION OF GFOUR CHARITIES PLUS, INC.

In compliance with Chapter 617, F.S. (Not for Profit)

2012 HAR 22 AH ID: I

The undersigned, a citizen of the United States, desires to form a Non-Profit Corporation pursuant to Chapter 617, Florida Statutes (Not for Profit) do hereby certify:

First: The name of the Corporation shall be GFOUR CHARITIES PLUS, INC.

Second: The street and mailing address in this state where the principal office of the Corporation is to be located is 10400 Griffin Road, #103, Cooper City, Broward County, Florida, 33328 or such other and additional locations as shall be designated by the Board of Directors.

Third: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
