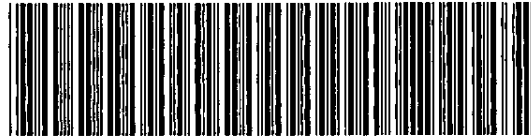



Article III:

The purpose of The J.O.Y of Life Enrichment Program is to enhance the quality of life for at risk youth and low income families by providing after school resources to promote self-discovery and healthy living by utilizing writing, reading and interactive workshops.

The J.O.Y of Life Enrichment Program is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distribution to organization that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the earnings of The J.O.Y of Life Enrichment Program shall inure to the benefit of, or be distributable to its directors, trustees, officers, or other private persons, except that The J.O.Y of Life Enrichment Program shall be authorized and empowered to pay reasonable compensations for services rendered and to make payments and distributions in furtherance of the purposes set forth in the articles hereof. No substantial part of the activities of The J.O.Y of life Enrichment Program shall be the carrying on of propaganda, or otherwise attempting to influence legislation and The J.O.Y of life Enrichment program shall not participate in, or intervene in (including the publishing of distribution of statements (and political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles The J.O.Y of Life Enrichment Program shall not carry on any other activities not permitted to be carried on a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section (1709c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. "Notwithstanding any other provision of these articles, The J.O.Y of Life Enrichment Program shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of The J.O.Y of Life Enrichment Program.

Upon the dissolution of The J.O.Y of Life Enrichment Program assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the state of local government, for public purpose.

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of The J.O.Y of Life Enrichment Program is then located, exclusively for such purposes or to such organization or organizations, such Court shall determine, which are organized and operated exclusively for such purposes.

1. Restrictions on Operations

- a. The J.O.Y of Life Enrichment Program will at all times be conducted as an organization described in section 501 (c)(3) of the Internal Revenue Code. The J.O.Y of Life Enrichment Program will not carry on any activities which are not permitted to be carried on by (1) a corporation exempt from federal income tax under 501 (c)(3) of the Internal Revenue Code, (2) a corporation eligible to receive tax-deductible contributions under section 170 (c) and

section 2055, 2522 or 2106, or (3) a nonprofit corporation organized under the laws of the State of Florida pursuant to the provision of Act s. 617.0202 as amended.

- b. No part of the assets or the net earnings of The J.O.Y of Life Enrichment Program may inure to the benefit of, or be distributed to its directors, trustees, officers, or other private persons, except that the corporation is authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of its charitable purposes.
- c. No substantial part of the activities of The J.O.Y of Life Enrichment Program will be carrying of propaganda, or otherwise attempting to influence legislation. The J.O.Y of Life Enrichment Program will not participate or intervene in any political campaign on behalf of or in distribute statements relating to political campaigns.

2. Dissolution and Disposition of Corporate Assets

- a. Upon termination, dissolution or winding up on the corporation, the Board of Directors will distribute all remaining assets of The J.O.Y of Life Enrichment Program for purpose or to an organization or organizations described in section 501 (c)(3) of the Internal Revenue Code.
