To Whom It May Concern:

I represent Global Mission Baptist Church (hereinafter “GMBC”). It appears that one or more of the following individuals have inappropriately altered the corporate filings for GMBC: 1) Kim, Durk Kee; 2) Lee, Bong Sun; 3) Pollard, Hye; 4) Denfeld, Mincha; 5) Boughman, Tan Chu; and 6) McGraw, Mihyang.

On February 11, 2024, GMBC had 27 total church members. Of the 27 church members, a 2/3 majority voted to remove the following individuals from membership and/or authority within GMBC: 1) Kim, Durk Kee; 2) Lee, Bong Sun; 3) Pollard, Hye; 4) Denfeld, Mincha; and 5) Boughman, Tan Chu, after these five tried to unilaterally remove the Pastor of GMBC and changed the locks to the church building. These five have unilaterally declared themselves as the “Gold Members” of the church and are hereinafter collectively referenced as such. Additionally, with regard to McGraw, Mihyang, this individual is not currently a member of GMBC.

Also on February 11, 2024, GMBC voted for the appointment of new church officers as follows: 1) Pastor Park, Young Kyu; 2) Pyon, Chung; 3) Walker, Kumsoon; 4) Zois, Yeji; 5) Brown, Aecha; 6) Supinger, Robert; and 7) Hong, Lesley. In conjunction with the GMBC church vote on February 11, 2024, GMBC filed its annual report with the Department of State, naming the seven (7) new church officers on Sunbiz.

Despite the results of the February 11, 2024, vote the Gold Members have continued their efforts to control GMBC, even repeatedly changing the locks to the church and calling the Crestview Police Department in an unsuccessful attempt to trespass GMBC’s pastor. On February 24, 2024, it


appears that the Gold Members, along with McGraw, Mihyang, amended GMBC's annual report to have the Gold Members along with McGraw, Mihyang, listed on Sunbiz as the corporate leadership for GMBC.

In response, GMBC held another meeting on February 25, 2024, and among other issues the members voted to reaffirm the removal of the Gold Members from authority and membership within GMBC and reaffirm appointment of new church leadership. A copy of the signed voting records from February 25, 2024, is attached with this letter, along with a copy of the Church's constitution and bylaws.

Since the February 25, 2024, meeting and its voting results, I have provided notification to the Gold Members and McGraw, Mihyang of the written voting records. I have further admonished everyone that providing false information to the Department is a felony offense pursuant to Florida Statutes Section 817.155. A copy of these letters has also been attached.

Under these circumstances, I respectfully request that the Department revert the business filing for GMBC to those as originally filed on February 11, 2024. Should the Department require any more information, I would be happy to provide as much as I have available. Thank you for your time and assistance.


