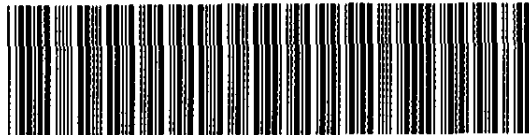

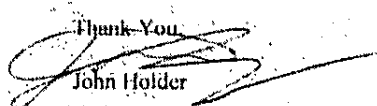

ARTICLE I. The name of the corporation is:

Run Run Track Club, Inc.

ARTICLE II. The principal place of business of this corporation shall be:

9930 Bay Vista Estates Blvd Orlando, Fl 32836

ARTICLE III The purpose for which the corporation is organized is:

(a) for the advancement of charitable, educational, and any other related or corresponding charitable purposes by the distribution of its funds for such purposes.

(b) To operate exclusively in any other manner for such charitable and educational purposes, as will qualify it as exempt organization under Section 501(c)(3) (or the applicable section of IRC related to the purposes for which organized) of the Internal Revenue Code, as amended, or under any corresponding provisions of any subsequent federal tax laws covering the distributions to organizations qualified as tax exempt.

(c) Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

(d) SAID ORGANIZATION IS ORGANIZED FOR CHARITABLE, EDUCATIONAL, AND SCIENTIFIC PURPOSES, INCLUDING, FOR SUCH PURPOSES, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.

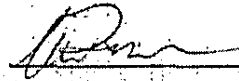
