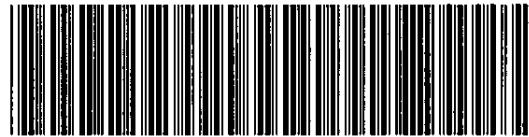

Or shall be distributed to the federal government or to a state or local government for a public purpose.
