

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit) 12 APR -6 AMII: 53

ARTICLE I NAME

The name of the corporation shall be TK Hoyaz, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address is 9924 N.W. 65th Manor, Parkland, Florida 33076.

<u>ARTICLE III PURPOSE</u>

The purposes for which the corporation is organized are:

- 1. To foster national or international amateur sports competition.
- 2. To conduct national or international competition in sports or to support and develop amateur athletes for that competition.

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected and appointed shall be stated in the Bylaws.

ARTICLE V

- 1. Notwithstanding any other provision of these articles, no part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
- 2. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the

county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
