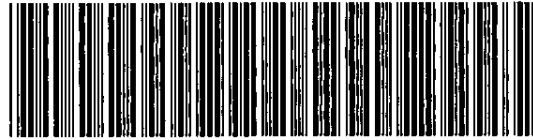



### ARTICLE I: NAME

The name of the corporation shall be:

### ARTICLE III: PURPOSE


