The undersigned, desiring to form a not for profit corporation under and pursuant to Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I

Name

Section 1.1. Name. The name of the corporation is **GOD'S FIRE AND RESCUE DEPARTMENT, INC.**, as a not for profit corporation.

ARTICLE II

Section 2.1. Principal Office. The principal office of the corporation is:

ARTICLE III

Purposes

Section 3.1. Purposes. This corporation is organized exclusively for charitable purposes of providing support for other non profits helping teens and children, donations of clothing and money to citizens that have lost their homes to fire, assisting local churches with member needs. The above corporation is also organized for the purposes of making contributions or donations to other § 501(c)(3) organizations within the meaning of the Internal Revenue Code, as may be amended and exempt from taxation under § 501(a) of the Internal Revenue Code, as may be amended. Any purposes expressed must conform to the requirements of I.R.C. § 501(c)(3) to receive tax exempt status.

ARTICLE IV

Directors

Section 4.1. Election/Appointment of Directors. The directors of the Corporation shall be elected in accordance with methods and qualifications specified in the bylaws of the Corporation. In no event, shall the number of directors be fewer than three.


Dissolution


