

Pursuant to the provisions of Section 617.1006, Florida Statutes, Mental Health Care Affordable Housing IV, Inc. adopts the following amendments to its Articles of Incorporation:

1. Article III is amended by deleting the existing Article III and replacing it in its entirety with a new Article III as follows:

ARTICLE III

Mental Health Care Affordable Housing IV, Inc. is organized exclusively for charitable, cultural, educational, health, scientific and public safety purposes. Subject to the foregoing, the corporation is an organization created to acquire and manage properties to provide affordable housing for low income families not otherwise able to afford safe housing.

2. A new Article VIII is added as follows:

ARTICLE VIII

Upon the dissolution of Mental Health Care Affordable Housing IV, Inc. assets of the corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

There are no members of the corporation. These Amendments were adopted by unanimous vote of its board of directors on May _2/____ 2015 and are effective upon the filing of the same with the Secretary of state of Florida.
