Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: To honor veterans of the United States Military through drill and ceremony. In addition, the organization's members will serve as mentors helping to foster the creative intellect of Junior and National Reserve Officer Training Corps Cadets.
