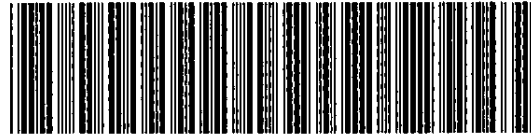

**ARTICLES OF INCORPORATION**  
In compliance with Chapter 617, F.S., (Not for Profit)

**ARTICLE I NAME**

The name of the corporation shall be:

Rape Crisis Center, Inc.

**ARTICLE II PRINCIPAL OFFICE**

Principal ~~street~~ address Mailing address, if different is:

503 Heinemann Street, Daytona Beach, FL. 32114

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

The purpose of the Rape Crisis Center is to lease, maintain and stock supplies for this house at 503 Heinemann St. to provide a community based setting in which the victims of sexual assault can come to and receive care from a multidiscipline team of responders. Law Enforcement, Advocates, Forensic Nurses and other responders can meet at the Rape Crisis Center to bring a holistic response to the primary and secondary victims of this crime. This Center will be physically supported through grants and donations.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

**ARTICLE IV DISTRIBUTION OF EARNINGS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE V DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**ARTICLE VI MANNER OF ELECTION**

Directors of the Rape Crisis Center, Inc. shall be appointed by the current serving directors.


