

ARTICLES OF INCORPORATION

OF

SJS SWIMMING, Incorporated

The undersigned incorporator, for the purpose of forming a corporation not for profit 501(C)(3) under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

Article I NAME

The name of the corporation shall be: **SJS SWIMMING, Incorporated.**

Article II PRINCIPAL OFFICE AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:
402 St. Johns Golf Drive, St Augustine, FL 32092.

Article III REGISTERED OFFICE AND AGENT

The address of the corporation's initial registered office and the name of its initial registered agent is James Zawacki, 1284 Stonehedge Trail Lane, St Augustine, FL 32092.

Article IV INCORPORATORS

The name and street address of the incorporator to the corporation is: 402 St. Johns Golf Drive, St Augustine, FL 32092.

Article V DIRECTORS

The number of the initial Board of Directors shall be Four (4). The number of Directors may be increased or decreased from time to time by bylaws of the corporation. The Board of Directors is hereby specifically authorized to make provision for reasonable compensation to its members for their services as directors, and to fix the basis and conditions upon which such compensation shall be paid. Any director of the corporation may also serve the corporation in any other capacity and receive compensation thereof in any form.

In furtherance, and not in limitation of the powers conferred by statute, the Board of Directors is expressly authorized to:

A. Adopt the initial Bylaws of the corporation. Further the Bylaws shall be adopted, altered, amended or repealed from time to time by the Board of Directors.

B. In general, to manage the affairs of said corporation in such a manner as shall be deemed advisable by said Board.

Article VII
PURPOSE

The purpose for which the corporation is organized is as follows: A 501(C)(3) to teach children to swim and be a member of an organized swim team.

Article VIII

POWERS

The Corporation shall have all of the common law and statutory powers of a corporation not for profit pursuant to the laws of the State of Florida that are not in conflict with the terms of these Articles; provided, however, that notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax pursuant to Section 501(c)(3) of the Internal Revenue Code, as amended, or the corresponding provision of any future United States Internal Revenue Law.

Article IX

LIABILITY

The Board of Directors of this Corporation is hereby specifically authorized to make provision of indemnification of directors, officers, employees and agents to the full extent

permitted by law.

Article XI
TERM

Corporate existence shall commence upon filing these Articles of Incorporation with the Secretary of State and the term of the Corporation shall be perpetual.
