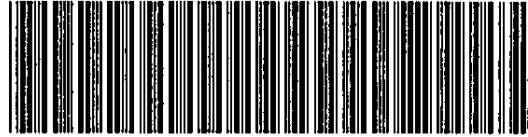

Article IX: Dissolution

The Corporation is governed by the statutes of Fundacion Niños con Futuro, a charitable Foundation in Ecuador. In accordance with the articles of the Ecuadorean Foundation, if the Foundation in Ecuador is dissolved or the Foundation decides to dissolve Niños con Futuro Corporation in the United States of America, the directors of the Corporation will appoint a liquidator or a liquidation committee, to be responsible for liquidation of the Corporation's assets.

The assets of the dissolved Corporation, or proceeds thereof, shall be transferred, after payment of liabilities, to one or more, not-for profit private sector institutions pursuing similar objectives as Fundacion Niños con Futuro. These institutions will be selected by the Directors of Ninos Con Futuro Corporation. No member of the Corporation, upon dissolution, shall have any claim to the assets of the same, not even those which they have donated, and therefore, can not receive any assets or proceeds at it's dissolution.
