# **ARTICLES OF INCORPORATION**

**In Compliance with Chapter 617, F.S.**

**OF**

## **MUSIC & DANCE UNTO THE LORD, INC.**

**(A NOT-FOR-PROFIT CORPORATION)**

The undersigned, acting as incorporators of a Corporation under the Not For Profit Corporation Act of the State of Florida, adopt the following Articles of Incorporation for such Corporation.

### **ARTICLE I - NAME**

The names of the corporation shall be:

**Music & Dance Unto the Lord, Inc.**

### **ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

**5153 Sterling Manor Drive  
Tampa, Florida 33647**

### **ARTICLE III - PURPOSE**

The purpose for which the corporation is organized is: To reconcile others to Jesus Christ through the arts. Principally to fellowship with national and international ministries, teach biblical principles, provide professional training in music and dance, provide a platform for arts ministries, worship and to share their talent while emphasizing ministry with the spirit of holiness. Additionally, this corporation shall have the ability to own, acquire, sell and maintain physical assets, as well as provide any and all services that are legal and permissible under Chapter 617, F.S.

### **ARTICLE IV - CORPORATE EARNINGS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III.

## ARTICLE V - DISSOLUTION

Upon the dissolution of the corporation or the winding up of its affairs, the assets of the corporation shall be distributed exclusively to one or more charitable, religious, scientific, testing for public safety, literary, or educational organization which would then qualify under the provisions of Section 501 (c)(3) of the Internal Revenue code and its regulations as they now exist or as they may be hereafter amended, or to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purposes.

## ARTICLE VI - INITIAL OFFICERS/DIRECTORS

The initial Board of Directors shall consist of at least three (3) members but no more than eleven (11), who need not be residents of the State of Florida. **The Board of Directors shall be elected as provided in the Bylaws.** The names, titles, and addresses of the persons who shall serve as Directors until the first annual meeting of members, or until their successors shall have been elected and qualified, are as follows:

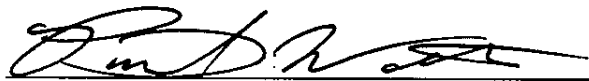
