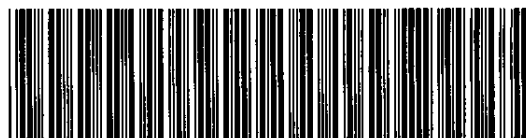

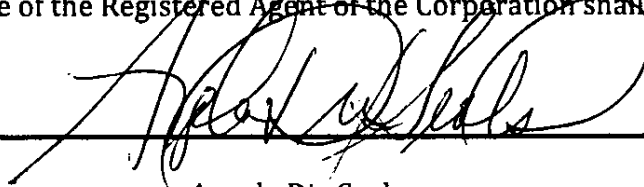

ONE: The name and address of this principal corporation is Impact Girls, Inc. at 3101 NW 25 Way, Oakland Park, FL 33309, in Broward County and the mailing address is P.O. Box 23051 Ft. Lauderdale, FL 33307. The corporation is organized pursuant to the Florida Non-Profit Corporation Code.

TWO: The purposes for which the corporation is formed are as follows: Youth Mentoring, conferences, workshops/seminars, and referrals to aid those in need of services outside the boundaries of Impact Girls, Inc.

THREE: The duration of this Corporation shall be perpetual, with no stock and shall have no members.

(3) Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local organization, for public purposes.

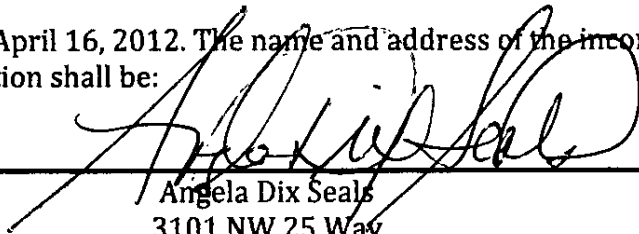

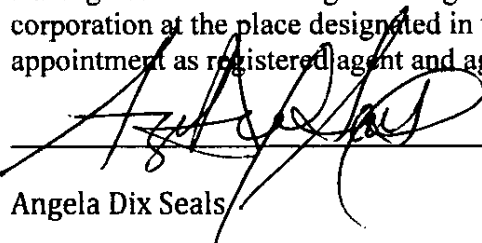
