Alleged Unauthorized Fraudulent Annual Report Changes

The false allegations are a result of intentional lying on the part of the accuser and are unsupported by facts. The statements made are being used to mislead and deceive the Florida State Department of Corporations. Ms. Little false allegations are being used to divert attention from her own guilt of unauthorized fraudulent activities. Since Ms. Little has decided to make False accusations and publish these statements against me, Valerie Smith, Reverend Glen Bostic and Mary Pearl Jones, we have decided to file a libel suit against her, and any other party involved. We believe that her statements damage our reputation, character, and integrity. We

will be seeking to recover damages from her and any other person(s) who utter these false statements. Ms. Little knows her statements are false. She has published this statement to harm the reputations of her targets to no avail. We will attach documents that will prove her allegations as false.

First, let's begin with some factual history.

- 1. I, Ernestine Price, am the Founder and Board President of Peter Pan Community Educational Center Inc.
- 2. Peter Pan was established as a not-for-profit corporation, document # N120000004095, FEIN # 45-5440136
- 3. The corporation was established June 30, 1965.
- 4. Ms. Little's birthdate is 12/09/1960, according to our records. (Appendix, page 1-2)
- 5. When the corporation was established Ms., Little was five years old, with an immature background knowledge which prevented her from establishing a corporation.

All of Ms. Little family member are bogus Board Member on. Her family members grew up with my children. So, Sherrie Vertil is younger than Cynthia Little so we can estimate that she was born after 1960. Paul Little, both girl's biological brother was born approximately 1959.

Jamere Rogers is this family niece who was born approximately 1989.

These family members know nothing about the origination of the Peter Pan non-profit Organization. The organization was established for those women that were migrant farm workers. They had to be to work to work before the sun came up. It was never established to satisfy one family's personal financial desires.

Venderee W. Pickett was a paid staff member of Peter Pan. She is also the birth mother of Cynthia Little and Sherrie Vertil (they are sisters). Sherrie Vertil will be mentioned later in this Document. As I now review paid staff vouchers. Venderee Pickett hired her daughter, Cynthia Little, June 1978, with a salary of S20,800 for 40 hours per week @ 52 weeks (about 12 months). I was told that Cynthia was originally hired as a cook. I found out through this document search that Cynthia was employed with the Sheriff's Department at the same time @ 40 hours a week at the same time as a cook. The Sheriff's Department should be able to verify

this information utilizing Cynthia Little social security number, A fraudulent signature, as Emestine Price, was signed authorizing the payments without my knowledge (Appendix, Page (1). I have never given anyone permission to sign my name on any document. Ms. Pickett died October 1997 at the age of 54. Another paid staff member was Linda V. Jones.

Ms. Jones died, July 2009 at the age of 64. The ages of those two women are very important because we were friends. I was the political activist, and I worked several jobs to maintain Peter Pan. Ms. Pickett and Ms. Jones sold dinners to help pay salaries of staff members in the Beginning until we were established with fundings. I believe during this period the false signing of my name begun.

In the upcoming years, Cynthia Little and Sherrie Vertil opened several unauthorized fraudulent account using Peter Pan non-profit information. I requested again and again the account information and requested that my name be included on the accounts. Cynthia always offered contradictions as to why my name could not be included. I also indicated that I wanted to establish a Board of Directors that represented overseeing the organization strategies, finances and operations, a Board of Directors that would ensure the organization financial responsibility and stability. Thus, I appointed Board members that processed certain attributes to help achieve those goals. Valerie Smith is a dissertation short of having a Ph.D. degree. She is skilled in correspondence and grant writing. Reverend Glenn Bostic is skilled in Building construction and has many contractor contacts. Mary Pearl Jones has a 20-year tenure with school Board of Broward County.

After establishing a reputable board, we were able to acquire documents that proved unauthorized and fraudulent use of Peter Pan non-profit agency to open several bank accounts with Sherrie Vertil and Cynthia Little names only on the acco

(First Union, TD Bank and Space Coast Credit Union.) (Appendix pages 3-43).

Cynthia and Sherrie Vertil have used the company credit card to change the official board members to her family members who are Paul Little (Brother) Jamere Rogers (niece) with the

.

Florida State Department of Corporation several times as they changed their address to 410 NW 14th Street, Pompano Beach, FL 33060 to divert the actual Board members' mail (Appendix, page 44) They have added Board members who were on the official Peter Pan Board member list on their list without their permission and diverted their address to an address that was not their home address, which is a violation of Florida Statute 775,082 775.083 and 775,084. The Space Coast account indicates 45 pages of Peter Pan Credit Card that was used for their personal family use daily transaction use for various eating establishments. Transaction deductions include Racetrack,

Marshalls Department store, Family Dollar, Walmart, Chevron gas station, Home Depot, Walgreens, Sunoco, Publix, Metro PCS (several different cell phone numbers), Wayfair Furniture (two large furniture transactions) FPL gas company payments, Comcast, light bill payments, Five and Below, CATO women clothing department store.

None of which benefited Peter Pan Corporation. In addition, <u>and a page of the page</u> belong to Sherrie Vertil. She is not affiliated with Peter Pan. However, she has assigned herself various Peter Pan Corporation titles. (Appendix, pages 44-50). Cynthia Little has also changed her title in the Corporation to fit her need.

Denard Price is my son. He never agreed to be on Peter Pan's Board. The address listed is Peter Pan's building address and was used to divert mailing information. The address given is not his home address. (Appendix page 57)

I have attached various check stubs signed by Cynthia Little from Appleseeds Performing Arts Academy. Cynthia Little did not have Peter Pan's official Board members' approval to receive rental funds from Appleseed. (Appendix pages 52 -58) None of the monies received from the Appleseed benefitted Peter Pan Organization. My son died. I received a 401K inheritance from his account. There are two buildings incorporated as Peter Pan Daycare. Utilizing my social security benefits and the allotment I received from my inherited 401K benefits, I repaired both roofs, paid over \$7,000 in back taxes and various bills. Due to the lack of investments, for both buildings there was so many necessary repairs for Peter Pan Daycare. The official Board began receiving the rental funds by contacting contractors. We contacted licensed contractors to complete repairs.

I have attached contractor information that verifies that the Board had hired to correct problems

I have attached contractor information that verifies that the Board had hired to correct problems in the Peter Pan Daycare buildings (Appendix, page 60 - 63). Finally, Cynthia Little and Paul Little has been officially removed from the Peter Pan Board due to years of pilfering and embezzlement.
