Articles of Incorporation of

BACK2SCHOOLPACKS4KIDS INC.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: To hold an annual event where donations are raised to provide a free event where families can have fun, cat food, listen to music, and where children receive a free backpack with school supplies inside among other items.
