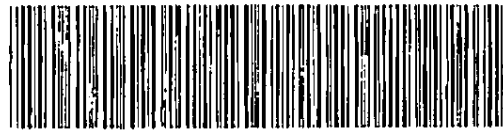

Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment(s) to its Articles of Incorporation:

**Article III-PURPOSE**

Section 1. The purpose of OASN, organized as a non-profit organization, is to facilitate the best outcomes for individuals with neurodevelopmental disorders. This is accomplished by offering educational programs, services, support meetings, events and referrals to the individuals, families & caregivers served. All that we do is lead by faith and hope to impact our community in a positive way.

*Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) or the corresponding section of any future federal tax code.*
