Articles of Amendment to
Article of Incorporation of
R3G Foundation Inc.

Pursuant to the provision of section 617. 1006, Florida Statutes, this Florida Not for **Profit Corporation** adopts the following amendments to its Articles of Incorporation.

## Article IX is hereby added and shall read:

No part of the net earnings of the corporation shall inure to the benefit of, or to be distributed to, its members, directors, officers, trustees, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c)(3) of the code, or the corresponding section of any future federal code, or (b) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the code, or the corresponding section of any future tax code.

# Article X is hereby added and shall read:

Upon the dissolution of the corporation, assents shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purposes. Any such asset not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
