





**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION  
OF VISTA LAGO OF PALM BEACH COUNTY HOMEOWNERS' ASSOCIATION, INC.**

Pursuant to the provisions of Section 617.1006, Florida Statutes, Vista Lago of Palm Beach County Homeowners' Association, Inc., a Florida not-for-profit corporation adopts the following Amendment to its Articles of Incorporation:

1. Article Ninth of the Articles of Incorporation of Vista Lago of Palm Beach County Homeowners' Association, Inc. is deleted in its entirety and replaced with the following:

**Ninth:** The officers who are to serve until the first election of the directors are as follows:

President	Amalia Papadimitriou
Vice President	Karl Albertson
Secretary	Robert Benware
Treasurer	Robert Benware


The first annual meeting of the Corporation and the first election of the Board of Directors shall be held in 2014 by order of the Board of Directors at such date as the Board of Directors may determine, and thereafter annual meetings of the members shall be held within thirteen (13) months of the prior annual meeting at a date and time as determined by the Board of Directors, so long as the day is not a legal holiday, or non-business day. The Directors elected at the first annual meeting and at each subsequent annual meeting of the Members shall elect officers of the Corporation who will hold office until the next meeting of the Board of Directors, or until their successors are elected and qualified.

2. That the sole Member of the Vista Lago of Palm Beach Homeowners' Association, Inc. did on August 21, 2013 vote to approve the proposed Amendment in accordance with the Articles of Incorporation and By-Laws of the Vista Lago of Palm Beach Homeowners' Association, Inc. which vote was sufficient for the adoption of said Amendment.

3. The date of this Amendment's adoption is August 21, 2013 and this


