



ARTICLE I: NAME

The name of the corporation shall be:

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE

The purpose for which the corporation is organized:

A non-profit, members only social club. Club members participate in recreational motorcycling, and other activities associated with fostering recreational motorcycling and brotherhood.

The existence of the Iron Rockets Motorcycle Club International, Inc. shall date from the approval of this Charter by the Secretary of the State of Florida, and shall continue in perpetuity.
