**ARTICLE I  
NAME**

The name of the corporation is KINGDOM BUILDERS MINISTRIES, INC.

**ARTICLE II  
DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE III  
PURPOSE**

The purpose for which the corporation is organized is for charitable, benevolent and religious purposes. There shall be no power to engage in any activity which would disqualify the corporation as an exempt organization under §501 of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

No part of the assets or the net earning of this corporation shall inure to the benefit of any private shareholder or individual; no substantial part of the activities of this corporation shall be carrying on propaganda, or otherwise attempting, to influence



Amendments to these Articles of Incorporation shall be made according to the procedure set forth within the By-laws for the corporation.

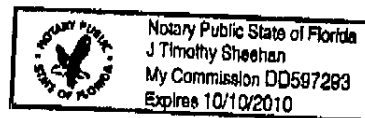
