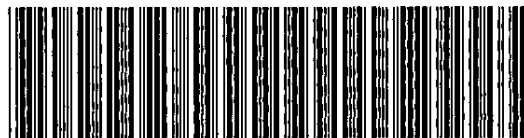

ARTICLES OF INCORPORATION

12 MAY -8 PM 4: 26

In compliance with Chapter 617, F.S., (Not For Profit)

ARTICLE 1 NAME:

The name of the corporation shall be: **WEST INVERRARY NEIGHBORHOOD WATCH INC.**

ARTICLE 11 PRINCIPAL OFFICE:

Principal street address: 7360 NW 37th Street, Lauderhill, FL 33319.

ARTICLE 111 PURPOSE:

The purpose for which the corporation is organized is: To maintain safety and security within the neighborhood. To increase awareness among residents, provide the education to residents on how to observe our surroundings, and to report all suspicious persons and their activities to the Lauderhill Police Department. To encourage mutual assistance among the neighbors to reduce crime, the fear of crime, to be the extra ears and eyes for the community, and the police as it relates to crime prevention. To build a stronger social organization among neighbors, to improve the quality of life in and around the community where our children and neighbors can live and play safely.

1. WEST INVERRARY NEIGHBORHOOD WATCH INC. is organized exclusively for charitable purposes more specifically to maintain safety and security of the neighborhood. The corporation shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the internal code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986, as now enacted and hereafter amended.

2. Upon the dissolution of this corporation, assets will be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code), or shall be distributed to the Federal government, or to a state or local government or a public purpose. Any such assets not so disposed of shall be disposed by the court of Common Pleas of the county in which the principal office of the corporation is located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.

ARTICLE IV MANNER OF ELECTION:

The manner in which the directors are elected and appointed: The initial directors and officers named in the articles of incorporation shall hold office until the first annual meeting, at which their successors are duly elected and qualified, or removed as stated in the bylaws.
