New Heart New Hope is a biblically-based organization located in the Tampa, Florida area that enables women to leave the degradation of the sex industry and to rebuild their lives for themselves and their children. It is a watchful personal case management program. It is an organization that provides transitional care for these women. This includes spiritual guidance, education, necessary financial help, counseling, life skills, case management, budgeting, job search skills, and addressing children's hurts. We help woman overcome backgrounds of abuse and addiction and provide opportunities for women in the sex industry to experience God's unconditional love and forgiveness and to become women whose hope is secure in Christ.

New Heart New Hope is about relationships. The new found friendships that are established between the volunteers and the social worker (mentor) will hold these women accountable. It is not about a completed task or handing out a check for assistance. We find that when the mother changes, the children change as well. Through the new examples of the mothers, the children gain new expectations for their own future. Therefore, the cycle of family dysfunction can be broken.

At New Heart New Hope our goal is to help women overcome the backgrounds of abuse and addiction by providing financial help for about 100 women in the first five years. A long term goal would provide assistance for 100 women a year with a full time counseling center and half-way house. We serve women who have been exploited in prostitution, brothels, and strip clubs. Some are part of the 300,000 women and children trafficked in America each year. Others are society's throw-a ways, some are runaways, and many are enticed by supposed friendships and easy money. The sex trade industry in this country is quickly becoming as lucrative as the illegal drug trade. The pimps force the women to tattoo their names on the women's

neck or arms; therefore they brand them like cattle so that others can see that these women are their property. They treat them as if they are expendable commodities. National research shows 90% of women in the industry were sexually abused as children. The average age that women begin to work in prostitution is 13.

Our services will include Wednesday night support meetings along with fellowship in which the women and their children will meet at a safe and secure place, preferably in a church building with a security guard. All volunteers will have background checks. There will be no contact with men. We will include separate meals for both the women and children and each program will include dinner, bible study, and life school. In the children's programs we will include tutoring. The women's life school will be on various subjects such as, addictions, abuse, sobriety, finances, forgiveness, meal planning, education, employment, budgeting, etc. There will be various women speakers to provide inspiration to them as well. We will also send out weekly support prayers through emails and receive weekly prayer request and pray for their needs.

When the women demonstrate their seriousness and attend regularly for several weeks the Wednesday night support group meeting, then the social worker will have an application filled out by the woman seeking support. This will include their finances, past sex work, health, past history. The limitations are that they can't be pregnant, no extreme mental health issues, and they have to have been sober from drugs and alcohol for 120 days, thus a signed consent to adhere to a drug test will be administered. The social worker will be the key relationship with these women. They will have regular meetings together to make sure each woman is keeping up with compliance, in which they will decide that plan of action together.

If all compliances are being met, then the protégé will continue to receive funding for rent, utilities, gas, groceries, and education as needed.
