I, John Rawlings, as the duly authorized Executive Director of Community Broadband Radio Association, Inc., submit this notarized statement of fact in support of the revocation of the organization's voluntary dissolution. On or about May 23, 2025, a voluntary dissolution of the corporation was filed by a former officer, Robert J. Malloy, without the consent or approval of the active board of directors, and during a period in which the corporation was undergoing a leadership transition. At the time of filing, Mr. Malloy was no longer acting in an official capacity, and the filing was made without proper board authority. The dissolution was not the will or intent of the current board of directors, nor was it in the best interest of the organization or the public we serve. The organization has remained operationally active in preparing for reinstatement and continuing its public service mission. We respectfully request that the Florida Department of State accept this Statement of Fact and the accompanying Revocation of Dissolution filing, and return the status of Community Broadband Radio Association, Inc. to Active.
