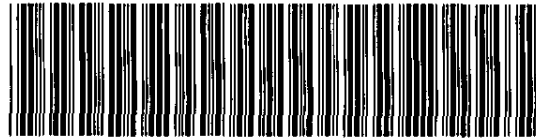

**ARTICLE OF INCORPORATION
FOR
DOUGLAS ANDERSON SENIOR HIGH SCHOOL-1959 ALUMNI CLASS, INC.**

ARTICLE I.

The name of this corporation is Douglas Anderson Senior High School -1959 Alumni Class, Inc.

ARTICLE II.

The mailing address shall be : 339 Brier Rose Lane, Orange Park, Florida 32065

ARTICLE III:

The corporation was organized for the general purpose pursuant to the Florida Corporation Not for-Profit Laws as set forth in chapter 617, Florida Status, and shall have perpetual existence.

ARTICLE IV:

The Corporation shall commence existence on the date these Articles are filed with the State of Florida.

ARTICLE V:

The purpose for which this corporation was organized are as follows:

- a. To operate in a manner which is supportive of educational efforts consistent with the criteria to qualify as an exempt organization under section 501(c)3 of the Internal Revenue Service.
- b. To develop, maintain, provide and participate in educational programs for the general public.
- c. To receive, and disburse funds and hold property for the purpose of the Corporation.

ARTICLE VI:

The number of Directors for this Corporation shall be not more than seven (7) and not less than five (5.)

ARTICLE VII:

The manner in which the Directors are elected or appointed shall be as set forth in the By-Laws of the Corporation, which were adopted at an initial meeting of the Class Members and the Board of Directors, on January 21, 2012.

ARTICLE VIII:

In the event of the disposition of any surplus or abandoned property of this Corporation, or upon dissolution, either voluntary or otherwise, the assets of this Corporation shall not inure for the benefits of any member or individual. But shall be transferred to one or more exempt organizations as described in section 501 (c)3 or 170 (c)2 of the Internal Revenue Code of 1986, or any future Internal Revenue law) that shall have as its primary purpose and responsibilities as specified in ARTICLE III.
