The name of the corporation is No on 3, Inc. The document number of the corporation is N112000005065.

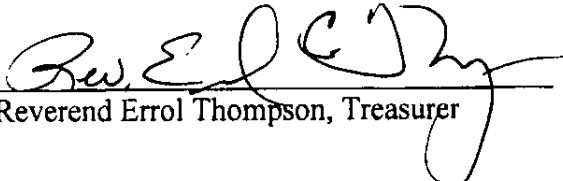
ARTICLE II
