Articles of Incorporation
Of
Guiding Light Outreach Ministries Inc.
A Florida "Not for Profit" Corporation

The undersigned, acting as incorporator of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

- I. The Name of the corporation shall be Guiding Light Outreach Ministries Inc.
- II. The principal office of the corporation shall be 1467 Cedar Pine Drive, Deltona FL. The office is located in Volusia County.
- III. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- IV. The method of selection of the Board of Directors and number of directors shall be stated in the bylaws.
- V. The initial Board of Directors is as follows:
 - a. Chair. Carolyn Horne, 32 Coquina Ridge Way, Ormond Beach, FL 32174.
 - b. Secretary. Ellen Johnson, 1308 B Water Willow Drive, Deland, FL 32720
 - c. Treasurer. June Davis, 40 Starling Trace, Crawfordville, FL 32327
- VI. The name of the registered agent is Jennifer Hill. Jennifer Hill resides at 1467 Cedar Pine Drive, Deltona, FL 32725.
- VII. The name and address of the incorporator is Jennifer Hill. Jennifer Hill resides at 1467 Cedar Pine Drive, Deltona, FL 32725.
- VIII. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for


public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

- IX. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
