**ARTICLE I**

**The name of the corporation is NORTH DAYTONA BEACH IRON WARRIORS  
MOTORCYCLE CLUB, INC.**

**ARTICLE II**

**The corporation is organized pursuant to the Florida Non-Profit Corporation Code.**

**ARTICLE III**

**The corporation is a not for profit corporation without voting members.**

**ARTICLE IV**

**The period of its duration is perpetual.**

**ARTICLE V**

**The Purposes for which the corporation is organized are:**

**To act as a philanthropic organization, to raise funds for other deserving non-profit organizations. The organization is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation (North Daytona Beach Iron Warriors Motorcycle Club, INC) shall ever inure to the benefit of any director or officer thereof or to the benefit of any private person.**

**For charitable and educational purposes only, as defined by Section 501(c) (3) of the Internal Revenue Code as amended, including the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 as amended, or the corresponding provisions of any future United States Internal Revenue Law.**

**To be limited to the acceptance only of any contributions, grants, gifts or proceeds and to then distribute such only qualified non-profit Corporations. The North Daytona Beach Iron Warriors Motorcycle Club, INC shall maintain detailed records of the receipt and expenditure of all funds received. Said distributions to qualified non-profit corporations shall be made after deductions for the cost of soliciting said contributions, grants, gifts or proceeds and for normal and reasonable administrative and operational costs incurred by North Daytona Beach Iron Warriors Motorcycle Club, INC. North Daytona Beach Iron Warriors Motorcycle Club, INC may hold assets in an endowment fund to carry out this purpose.**

#### **ARTICLE VI**

**A majority of the Board of Directors shall be active or retired law enforcement officers or**

**firefighters, pursuant to the bylaws enacted by the North Daytona Beach Iron Warriors Motorcycle Club, Inc.**

**The initial directors shall serve for a term of (2) years. At the end of a (2) year term, the North Daytona Beach Iron Warriors Motorcycle Club, Inc. members will have a majority vote to keep or replace directors, as stated in the North Daytona Beach Iron Warriors Motorcycle Club, Inc. by-laws..**

#### **ARTICLE VIII**

#### **ARTICLE IX**

**No part of the net earnings of the corporation shall inure to the benefit of, or be Distributable to its members, directors, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in article V hereof. No substantial part of the activities of the corporation shall be to carry on propaganda, or otherwise attempt to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidates for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code of 1954, as amended, (or the corresponding provision of any future United States Internal Revenue laws) or (b) by a corporation, contributions to which are deductible under Sections 170 (2)(2) of the Internal Revenue code of 1954, as amended (or the corresponding provision future United States Internal Revenue Laws).**




**ARTICLE X**

Upon the dissolution or liquidation of the corporation, the Board of Directors shall, after paying or making provision for payment of all of the liabilities of the corporation, give the assets of the corporation to a charitable non-profit corporation if that Corporation shall, at the time, qualify as an exempt organization under Section 501 (c) (3) Of the Internal Revenue Code of 1954, as amended (or the corresponding provision of any future United States Internal Revenue Law). Any such assets not disposed of shall be disposed of by the Superior, State or Probate Court of Flagler County, Florida, exclusively to such organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended (or the corresponding provision of any future United States Internal Revenue Law). The court shall utilize the doctrine of Cy-Pres in determining which organizations to choose.


