# ARTICLES OF INCORPORATION OF

# PHILIPPINE INDEPENDENT CHURCH DIOCESE OF TAMPA, INC.

In compliance with Chapter 617, F.S., (Non-Profit)

#### **ARTICLE I - NAME**

The name of the Corporation is PHILIPPINE INDEPENDENT CHURCH DIOCESE OF TAMPA, INC., (hereinafter "Corporation").

# ARTICLE II - PRINCIPAL OFFICE

The principal office of this Corporation is 14322 N Boulevard; Tampa, FL 33613 and the mailing address is the same.

# **ARTICLE III - PURPOSES**

Section 1 - The Corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Section 2 – The Corporation shall also serve as one of the dioceses or local churches of the Iglesia Filipina Independiente or the Philippine Independent Church in the United States of America and Canada composed of parishes and missions within the jurisdiction approved by the General Assembly and which shall fully adhere to the 1977 Constitution and Canons of the aforementioned Church.

#### **ARTICLE IV - PROHIBITIONS**

Section 1 - No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from

corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Section 2 - To exercise all rights and powers conferred on Not-For-Profit Corporations under the laws of the State of Florida, including the power to contract, rent, buy or sell personal or real property, provided, however, that the Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of this Corporation.

#### ARTICLE V - MANNER OF ELECTION

The Diocesan Council, (hereinafter "Board of Directors") shall be elected in accordance with the provisions provided for by the 1977 Constitutions and Canons of the Church forming in full as the Corporation's By Laws.

Neither the members nor the members of the Board of Directors or officers of the Corporation shall be liable for the debts of the Corporation.

#### ARTICLE IX - EFFECTIVE DATE

These Articles of Incorporation shall be effective immediately upon approval of the Secretary of State, State of Florida.

#### ARTICLE X - AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors and affirmed by a convention as provided for by the By Laws of the Corporation.

## ARTICLE VI I – DISSOLUTION

Upon the dissolution or winding up of the Corporation its assets remaining after payment, or provision for payment, of all debts and liabilities of this Corporation shall be turned over to the Iglesia Filipina Independiente or Philippine Independent Church or distributed to a Not-For-Profit Fund, Foundation or Corporation affiliated to the aforementioned Church which is organized and operated exclusively for religious and charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.
