### ARTICLES OF INCORPORATION

#### **AMENDED 12-13-2013**

# NAME AND LOCATION OF PRINCIPAL PLACE OF BUSINESS

The name of this Corporation shall be Circle of Life Helping Women and Children, Inc. hereafter referred to CLHWC.

The location of its principal place of business shall be 923 Dozier Avenue, Sebring, in Highlands County, Florida 33875 or at such other place or places as it designates from to time.

#### **ARTICLE II**

#### PURPOSE FOR WHICH THIS ORGANIZATION IS ORGANIZED

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### **ARTICLE III**

### TERM OF EXISTENCE

This corporation shall have perpetual existence, unless sooner dissolved according to law.

## ARTICLE IV

# DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one of more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
