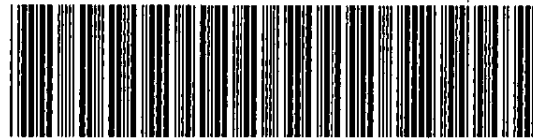

Sunergos Corporation will bridge the gap and help to ensure every student, regardless of resources, has the support to succeed academically. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its educational purpose. Notwithstanding any other provision of these Articles, Sunergos Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, Sunergos Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of its corporate purpose. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.
