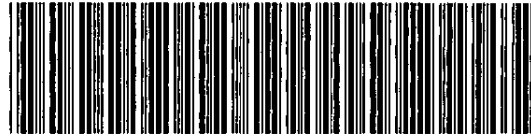

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Bat Belfrys was formed to promote the preservation and conservation of Florida's bat species by:

1. Providing safe and humane exclusion practices, bat houses, and other activities related to bat conservation, including but not limited to habitat restoration;
2. Educate the public by providing a forum for the exchange of ideas and knowledge regarding Florida's native bat species and their protection and conservation;
3. Provide recommendations to governing bodies regarding issues that concern bats and/or their habitats, including but not limited to, conservation, habitat protection, and public policy.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected and appointed:

Directors shall be appointed at an annual meeting to be held within the first quarter of each year, January 1 thru March 31. Appointment will be based upon willingness to serve in a voluntary, uncompensated capacity for a period of at least two (2) years. The governing Board shall consist of between 4 and 12 Directors and Officers.

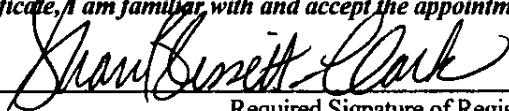

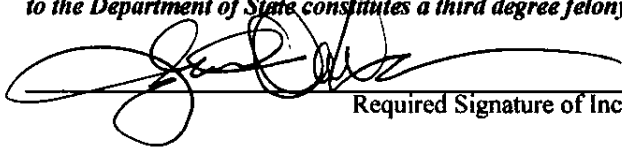
