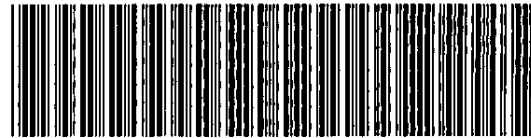

ARTICLES OF INCORPORATION  
In Compliance with Chapter 617, F.S., (Not for Profit)

1. ARTICLES OF INCORPORATION of ISALIAH LAWSON SCHOLARSHIP FOUNDATION, INC.

The undersigned, acting as incorporator of a corporation under the Not for Profit Corporation Act of the State of Florida, adopt the following articles of incorporation for such corporation:

2. NAME OF THE CORPORATION

The name of the corporation hereinafter referred to as the "Corporation" is ISALIAH LAWSON SCHOLARSHIP FOUNDATION, INC., whose principal office is located at 6129 Misson Drive, Orlando, FL 32810.

3. PERIOD OF DURATION

The period duration of the Corporation is perpetual.

4. PURPOSES OF THE CORPORATION

The Corporation is organized exclusively for educational purposes and including, for such purposes, the making of distributions to individuals and to organizations that qualify as exempt organizations under section 501(c)(3) of the internal revenue code, or the corresponding section of any future federal tax code.

5. EARNINGS

No part of the net earnings of the Corporation shall insure to the benefit of, or be distributable to its members, trustees, officers or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of the purposes of set forth in Article 4 hereof. No substantial part of the activities of the Corporation shall be the carrying on in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

6. DISSOLUTION

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

7. QUALIFICATION FOR MEMBERS

The qualification for members and the manner of their admissions shall be regulated by the Bylaws.
