STATTEMENT ON THE METHOD OF ELECTION OF DIRECTORS:

2.0 ELECTION OF OFFICERS

Nominations will be opened at the September general meeting and close just prior to the election at the November general meeting. Nominations and ballots will be published in the November newsletter. The election will be held at the November meeting with the results announced at the end of the meeting. Officers will be installed at the January meeting. Each officer shall serve for a term of one year from the date of his or her installation and until his or her successor is duly elected and qualified. In the month of October the Grand Amir will select a nominating committee, subject to the confirmation of the Executive Board. The election of officers shall be a simple plurality of ballots presented to the Secretary during the November meeting.

Officers must be members in good standing at the time of their election and must maintain their good standing throughout their term of office.
