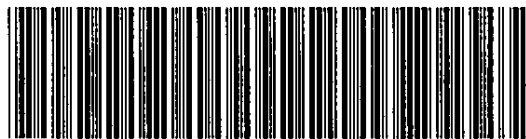

Global Mission for Children is a not-for-profit church/mission to help poor children all over the world with an emphasis in Africa by providing and advancing education, necessities like clothes, medicine, basic meals like porridge and rice and teaching the children in schools that our missionaries built. We have churches in Newburyport, MA and Bradenton, FL with missionaries all over the world. We will solicit donations from individuals as well as corporations as the need is incredibly great and the situation is dire. We are a Christian Church that believes the Scriptures, both Old and New Testament, are the inspired Word of God. We therefore affirm the Holy Bible is God's Word available to His people today and that it is the complete revelation of His will for salvation and the divine and final authority for all Christian faith and life.

We believe in one living and true God, eternally existing in three persons, the Father, the Son, and the Holy Spirit that these are equal in every divine perfection. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes to make payments and distributions in furtherance of the purposes set forth in the Statement of Purpose hereof. The property of this corporation is irrevocably dedicated to [your 501(c)(3) exempt purpose(s)] and not part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual. Global Mission for Children will not engage in prohibited political and legislative activity under 501(c)(3); No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation. If dissolved, will distribute its assets within the meaning of 501(c)(3): Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose.

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida.

The specific purpose for which this corporation is organized is to publish a website to solicit donations, providing church services both in our church buildings and online, and provide funds to our missionaries in Africa specifically but all over the world as we deem necessary. The term for which this church shall exist shall be perpetual.
