ARTICLES OF INCORPORATION FOR IBIS CHARITIES, INC. (Not-For-Profit)

The undersigned, desiring to form a charitable corporation under Chapter 617, Plorida Statutes, as amended, the Florida Not for Profit Corporation Act, does hereby adopt the following Articles of Incorporation and certify:

ARTICLE I NAME

The name of the corporation shall be IBIS CHARITIES, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE
