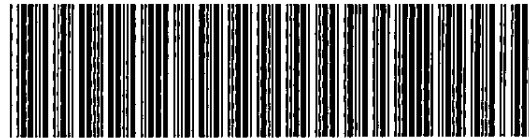

Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned incorporators hereby adopt the following Articles of Incorporation:

Article I - Name

The name of this corporation shall be Global Orphans Welfare Organization, Inc.

Article 2 - Principal Office

Article 3 - Purpose

The purposes for which this corporation is organized are: This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the Nonprofit Corporation Law of Florida, provided, however, that the corporation shall only engage in acts or activities that are consistent with and in furtherance of its 501(C)(3) tax-exempt purposes, which are described in other provisions of these articles.

Article 4 - Manner of Election

The manner in which the directors are elected and appointed for this corporation is as stated in the bylaws.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(C)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section (170)(c)(2) of the Internal Revenue Code.
