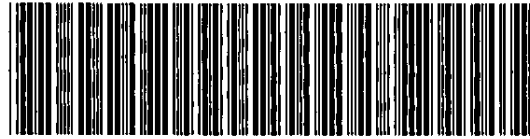

Pursuant to the provisions of section 617.1006, Florida Statutes, this **Florida Not For Profit Corporation** adopts the following amendments to its Articles of Incorporation:

A. ARTICLE II – The principle place of business address is changed to the following:

B. ARTICLE III - PURPOSE is replaced with the following:
