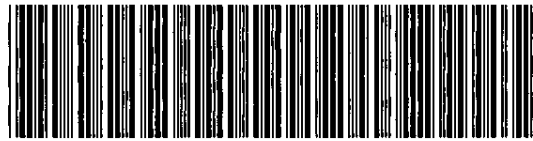

The purpose for which the corporation is organized is:

The Purpose and Objectives of D.I.V.A.S Club Corp. Shall Be:

- To the advancement of any and all correspondent educational, religious, scientific and charitable purposes.
- To Give primacy to the human and spiritual, rather than to the material value of life.
- To encourage the daily living in all human relationships and Promote Healthy and Strong Families by empowering individual with a self acceptance.
- To develop, by precept and example, a more intelligent, aggressive, and serviceable citizenship.
- To cooperate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice, patriotism, and goodwill.
- The main purpose for which this D.I.V.A.S Club is organized to receive cash and non cash contributions such as clothing, household items is to assist people in the community and in some specific cases to assist people in other countries.
- To provide, Through D.I.V.A.S Club, a practical means to form enduring friendships, to render altruistic service, and to build better communities.
- To promote the adoption and the application of higher social, business, and professional standards.
- The fundraisers funds collected by the organization shall be used toward created events to be resold to raise funds to finance the ACCEL Educational/Leadership programs and buy ACCEL Educational Books as well providing individual/group counseling workshops against Domestic Abuse, Battered women/men and children, as well as youth/adult Scholarships.
- To receive assistance, money (as grants or otherwise) real or personal property and any other form of contribution, gifts, bequest or devise from any person, objects and purposes of this Corporation; to enter into agreements or contract for contributions to the corporation for its objects purposes, provided, however, that gifts shall be subject to acceptance by the Board of Directors as required by the bylaws.
- To help prevent intimate partner violence though community education, speaking forums/engagements/public awareness and advocating for the development of a comprehensive coordinated approach to reducing all domestic, as well as work toward

facilitating enforcement and understanding of the laws, policies, and procedures applicable to domestic violence.

- The mission is to provide education, to the National Coalition against Domestic Violence and support against domestic abuse and Battered Women/men and Children and families; with individual, group counseling “by Holistic approach” and Empowerment Educational programs and workshops.
- Implant and establish D.I.V.A.S Clubs at Districts, national wide and worldwide.
- As well promoting; ACCEL Educational Youth/Juvenile Leadership Skills Program is designed to build social skills and leadership taints for youth/juveniles to be productive contributors to society. Working closely with the youth to help provide tools and skills that are essential to Character Building, as well Life Skills Training, and Tools for Decision Making, Accountability, and Responsibility. No matter what a student’s circumstance is at school or home, the program will help each student get back on track and focused! We believe ALL students, regardless of their circumstance can be successful if they are given the tools and time to change.
- D.I.V.A.S Club includes a teenagers club, named T-Club.
- To support missionaries and professional, camps and academic institutions to conduct examinations to qualification candidates, for such purpose as specified in section 501 (c) (3) of the Internal Revenue Code. As well carry out Food distributions to the needed families of the community, and organizations that qualify as exempt organization under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV MANNER OF ELECTIONThe manner in which the directors are elected and appointed:

The officers and members shall be elected by the active members of the organization, the annual business meeting by a two-thirds (2/3) majority vote of the active membership, who have paid their current annual dues and participation at such meetings. “Officers must meet the D.I.V.A.S CALL qualifications” in these Bylaws. Officers shall be elected for a one year terms of office. Officers may serve a second term if elected, or more consecutive term, if elected, but no more than 3 years. Founder/Trustee C E O shall hold lifetime. ACCEL Education Counsel/Affair Specialist shall hold three (3) years term or longer. International D.I.V.A.S Clubs consult Governor shall hold three (3) years or longer. State D.I.V.A.S Clubs consult Governor shall hold three (1) year term may serve a second years if elected, but no more than 3 years. District of Division D.I.V.A.S Clubs Lieutenant Governor/Pass President of D.I.V.A.S Clubs shall hold one (1) year term offices. The Fund Development Specialist Officer shall hold three (3) years term. Election of Chief Executive Board and Trustee: Dr. Maria Pinto Barbosa Has the right to choose the potential officer/Director, to occupy her position; only at the time she decide to retreat or retire. The authority and duty of each officer/director shall be such as are defined in the job description of each position.
