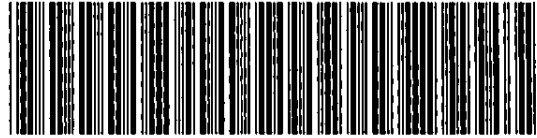

ARTICLES OF INCORPORATION
(In Compliance with Chapter 617, F.S., (Not for Profit))

Article I - Name

The name of the organization shall be **Helping Our People Exceed, Inc.**

Article II - Principal Place of Business

The principal place of business and mailing address of the corporation shall be
108 Henderson Road, Tallahassee, Florida 32312.

Article III - Purpose

The purpose and mission for which the organization is organized is ministering to the person's mind, body and soul, thus reaching the total person through mentoring, teaching and training which will empower the community. Said organization is organized exclusively for charitable and religious purposes.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
