Articles of Incorporation

of

The undersigned subscribers to these Articles of Incorporation, desiring to form a Not-For-Profit corporation under the laws of the State of Florida, do hereby accept all of the rights and privileges, benefits and obligations conferred and imposed by said laws and hereby adopt the following Articles of Incorporation as the Charter of the Corporation hereby organized.

Article I. Corporate Name

The name(s) of this Corporation shall be:

Article II. Terms of Existence

This corporation shall have perpetual existence

Article III. Purposes and Powers

Said corporation is organized exclusively for charitable, health, and educational, religious or scientific purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code. To present a set of programs, projects, services, seminars, lectures and performances pertaining to arts, variety entertainment and health and wellness. To provide Youth academic assistance and tutorials, education, technique and training in the arts (music/dance/drama), health, fitness and wellness. To create cultural experiences that exposes participants to the arts and entertainment fields to include; but not be limited to music, dance, drama, vocal coaching and other practical exercises in the arts. Audio/visual recording for practical experience, exposure and exploitation in the future. To cultivate an outlet for creativity in playwriting, song composition, arranging, staging, wardrobing, auditions, production, production management, promotions, advertising, marketing, and public relations. To further create showcases, recitals, and public productions. To address the special needs for those with limited abilities (specch/hearing/sight) and/or those with other disabilities. To create sound minds and bodies through health and wellness education and practices.

Notwithstanding any other provision of the Articles, the corporation, shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes with the meaning of Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.
