ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF TAMPA BAY AREA GUITAR SOCIETY, INC. (a Florida Not For Profit corporation) Document Number N12000005630

SECOND: The following amendments to the Articles of Incorporation were adopted by the Board of Directors of the Corporation by Written Consent in Lieu of Special Meeting of the Board of Directors effective as of November 2, 2018:
