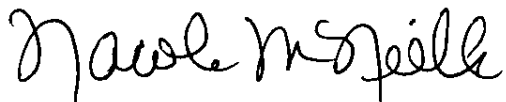

ARTICLES OF INCORPORATION

OF

KEY2LIFE WELLNESS COALITION, INC.

Article I - NAME

The name of the corporation shall be Key2Life Wellness Coalition, Inc., a Corporation not for profit organized under the laws of the State of Florida.

Article II – PRINCIPAL OFFICE

The principal and mailing address of the Corporation shall be Key2Life Wellness Coalition, Inc., 1308 Willow Branch Avenue #11, Jacksonville, FL 32205.

Article III – PURPOSE

The purpose for which the corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation is organized to provide and promote educational opportunities and activities that target individual health and wellness concepts for families living in the United States and abroad by partnering with communities, agencies, and organizations.

Article IV – MANNER OF ELECTION

The manner in which the directors are elected or appointed will be provided in the bylaws of the corporation. After incorporation, the initial directors shall hold an organizational meeting, at the call of the incorporator, to complete the organization of the corporation by appointing the remaining officers, adopting bylaws, and carrying other business brought before the meeting.

Article V – INITIAL DIRECTORS AND/OR OFFICERS

Article VI – LIMITATIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VII – DEDICATION OF ASSETS

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the country in which the principal office of the corporation is then located, exclusively for such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
