



WHEREAS, it is deemed to be desirable and in the best interest of this Corporation and its shareholders that it be incorporated pursuant to the Florida Non-Profit Corporation Act, Chapter 617; now, therefore, be it

RESOLVED, that certified copy of the original Articles of Incorporation for such corporation be attached hereto and that the following Articles of Incorporation for such corporation be and hereby adopted as follows:

The undersigned, acting as incorporators of a Florida corporation under the Florida Non-Profit Corporation Act, Chapter 617, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME. The name of this corporation is **THE WILLIAMS TEMPLE CHURCH OF GOD IN CHRIST OF FORT LAUDERDALE, FLORIDA, INC.**

ARTICLE II

PRINCIPAL OFFICE. The principal place of business and mailing address of this corporation shall be **744 N.W. 12th Street, Fort Lauderdale, FL 33311.**


