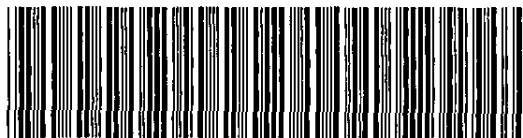



Article III: The corporation is organized and operated exclusively to carry on one or more exempt functions as defined in Section 527 of the Internal Revenue Code of 1986, as amended, including the function of influencing or attempting to influence the selection, nomination, election, or appointment of any individual to any federal, state or local public office or office in a political organization, or the election of Presidential or Vice Presidential electors, whether or not such individual electors are selected, nominated, elected or appointed.

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the corporation, dispose of excess funds in accordance with 2 U.S.C. §439(a) and 26 U.S.C. §9038, and all of the other assets of the corporation by transferring them to persons or entities which at the time qualify under Section 527 of the Internal Revenue Code of 1986, as amended, or any corresponding provision of any future United States Internal Revenue law, or any charitable organization or any governmental entity as the Board of Directors may determine.


