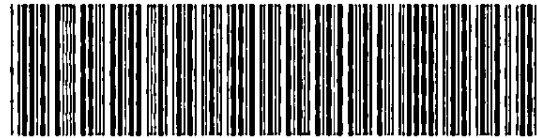

1. The following sentence in Article III of the Articles of Incorporation of Trevi at the Gardens Homeowners' Association, Inc. is hereby amended to read in its entirety as follows:
