Article I - Name

- The name of this corporation shall be: Pinellas County Fair Foundation, Inc.

Article II - Principle Office

The principal place of business of this corporation is 1375 S Pasadena Ave #123, St. Petersburg, FL 33707. The mailing address of this corporation is Post Office Box 35, Dade City, Florida 33526.

Article III - Purpose

The primary purpose of the corporation shall be to provide charitable services to the needy in Pinellas County, Florida, with efforts primarily geared towards children. The corporation is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Notwithstanding any other provision of this document, the corporation shall not carry on any activity not permitted to be carried on by an organization exempt under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding future federal tax code.

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
