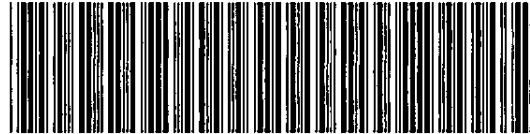

ARTICLES OF INCORPORATION
Of
MISSION POSSIBLE OUTREACH SERVICES, INC.

A General Not For Profit Corporation

The undersigned subscriber of these Articles of Incorporation, a natural person competent to contract, hereby shall form a corporation under the laws of the State of Florida.

ARTICLE I – CORPORATE NAME

The name of the corporation is: Mission Possible Outreach Services, Inc.

MISSION POSSIBLE OUTREACH SERVICES, INC.

ARTICLE II – PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III – PURPOSE

1. Mission Possible Outreach Services, Inc. is organized exclusively for charitable purposes, including the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future code.
2. Mission Possible Outreach Services, Inc. is an organization specifically dedicated to eliminating homelessness and hunger on a local, state, and global level. This will be accomplished through lectures and slideshows in schools, libraries, and other public venues as well as social media, and the non-profit's website.
3. Mission Possible Outreach Services, Inc. shall distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code of 1986, as amended.
4. Mission Possible Outreach Services, Inc. will not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code of 1986, as amended.

ARTICLE IV – RESTRICTIONS

1. No part of the net earnings of Mission Possible Outreach Services, Inc. shall be used for the benefit of, or distributed to its members, trustees, or officers, except that reasonable compensation for services rendered, and the furtherance of the purpose of Mission Possible Outreach Services, Inc.
2. No substantial part of the activities of Mission Possible Outreach Services, Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation. Mission Possible Outreach Services, Inc. also shall not participate in, or intervene in any political campaign on behalf of any candidate for political office.
3. Mission Possible Outreach Services, Inc. shall not carry on any activities not permitted to be carried on by an organization exempt from federal tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
4. Mission Possible Outreach Services, Inc. will not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code of 1968, as amended.
5. Mission Possible Outreach Services, Inc. will not make any investments in such a manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1986, as amended.
6. Mission Possible Outreach Services, Inc. will not make any taxable expenditure as defined in Section 4945(d) of the Internal Revenue Code of 1986, as amended.

ARTICLE V – DISSOLUTION

Upon the dissolution of the organization, all assets will be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of Mission Possible Outreach Services, Inc. is then located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VI – MANNER OF ELECTION

The registered agent of the corporation will appoint all of the directors.
