## ARTICLES OF INCORPORATION OF

### TIMELESS GUARDIAN SERVICES, INC. In Compliance with Chapter 617, F.S., (Not-for-Profit)

#### **ARTICLE I- NAME**

The name of this Corporation is TIMELESS GUARDIAN SERVICES, INC.

#### ARTICLE II- PRINCIPAL OFFICE

#### ARTICLE III- NATURE OF BUSINESS

#### ARTICLE IV- MANNER OF ELECTION OF DIRECTORS

The manner in which the Directors are qualified, elected or appointed is as follows: Each year at its General Annual Meeting, the members of the Corporation shall elect a Board of Director to serve for the ensuing year as provided for in the by-laws.
